SUBJECT : ATTENDANCE TO THE 9TH COMMUNITY-BASED MONITORING
 SYSTEM (CBMS) – PHILIPPINES NATIONAL CONFERENCE

The CBMS Network Coordinating Team of the De la Salle University (DLSU)-Angelo King Institute (AKI) for Economic and Business Studies in partnership with the Department of the Interior and Local Government (DILG) will hold the 9th CBMS National Conference on January 22-24, 2013 at the SMX Convention Center, Seashell Lane, Mall of Asia, Pasay City.

The event will gather about 600 delegates to further strengthen growing partnerships among national government agencies, local government units, academe and research communities, non-government organizations, civil society organizations and other development partners on the use of CBMS data as a primary tool in generating information to identify targets and beneficiaries of poverty reduction and pro-poor programs and projects of the local government units and as an input in the local planning and budgeting processes.

This year's conference will feature LGU presentations on the use of CBMS for local planning, budgeting and program implementation, poverty monitoring, impact evaluation, contributions on the achievement of the millennium development goals (MDGs), disaster risk reduction management/climate change adaptation (DRRM/CCA) and improving local governance as well as exhibit of photos, videos and publications on CBMS. Among the highlights of the conference are the *Awarding of Best Practices on CBMS Implementation* and the *Launching of Latest CBMS Publication on the Many Faces of Poverty Volume 4*.

In view thereof, all Local Chief Executives (LCEs) and other local officials are strongly encouraged to attend the CBMS National Conference. Live-out conference fee is P4,500.00/person which will cover conference kits, lunch and snacks. Early bird rate of P3,900/person may be availed of participants who will submit complete registration forms and payments not later than December 15, 2012.
