COMELEC RESOLUTION ON LOCAL ABSENTEE VOTING

SYSTEM AND OTHER RESOLUTIONS CONCERNING THE

MAY 2016 ELECTIONS

Pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Executive Order No. 157, Republic Act No. 7166, Republic Act No. 10380, and other pertinent election laws, the Commission on Elections (COMELEC) is preparing for Local Absentee Voting for the May 9, 2016 National and Local Elections.

Relative thereto, all concerned are hereby encouraged to help in disseminating COMELEC Resolution No. 10003 promulgated on October 15, 2015 entitled *Rules and Regulations on Local Absentee Voting in Connection with the May 9, 2016 National and Local Elections*, including the Application To Avail of Local Absentee Voting (LAV Form No. 01) and List of Applicants for Local Absentee Voting (LAV Form No. 02).

All duly accomplished application forms and certified Lists of Applicants shall be transmitted **not later than March 7, 2016** to the Committee on Local Absentee Voting (CLAV) of the COMELEC.
