COMMEMORATING THE "SAVE SIERRA MADRE DAY" ON SEPTEMBER 26

OF EVERY YEAR PURSUANT TO PRESIDENTIAL PROCLAMATION NOS.

413 (S. 2012) AND 233 (S. 2011)

Presidential Proclamation No. 413 dated June 19, 2012 declared September 26 of every year as "Save Sierra Madre Day," to help boost awareness among the general public on the importance of preserving our forests, as well as, protecting, managing and properly utilizing the natural resources of the country. The commemoration of Save Sierra Madre Day will provide an avenue to remind local governments and their constituents of the risks and dangers that may result from lack of concern and inaction for our environment and natural resources as experienced during the onslaught of Typhoon Ondoy in 2009.

In this connection, all Provincial Governors, City Mayors, Municipal Mayors and Punong Barangays are enjoined to commemorate this year's "Save Sierra Madre Day" by way of undertaking activities, such as, but not limited to:

- 1. Joint celebration with civil society groups, people's organizations especially farmers, schools, church groups and indigenous peoples (IPs) communities, to include tree-planting and related activities;
- 2. Outdoor programs, or the conduct of a symposium, where video sharing materials on biodiversity, beautification and cleanliness, building plant nurseries can be done:
- 3. Staging plays like the "Kalikasan ay Pag-asa" by the Kalipaya Ministry and Pope Francis' Laudato Si on how to take care of our common home; and
- 4. Promoting simple lifestyle and sustainable environment management through conserving water and energy, reporting/preventing illegal logging and fishing, segregating wastes and patronizing organic farming.
