Memorandum Circular No. 2017-103 August 15, 2017

1.0 Background

The Dangerous Drugs Board (DDB), as the lead agency in policy making and strategy formulation on drug prevention and control, in support of the Comprehensive Dangerous Drugs Act of 2002, or R.A. No. 9165, developed a web enabled system to collect, manage and analyze data and information on drug abuse prevention called the Integrated Drug Monitoring and Reporting System (IDMRIS).

The system monitors the implementation of anti-drug policies and programs of different national agencies, local government units, and partner groups and organizations. It also serves as a venue for reporting drug abuse prevention and control programs for implementers. In addition, the system will help DDB in the analysis and evaluation of data for evidence-based decision making and appropriate government policies and strategy against illegal drugs.

2.0 Purpose

This circular enjoins Local Government Units to support the Integrated Drug Monitoring and Reporting System (IDMRIS).

3.0 Scope/Coverage

All Provincial Governors, City and Municipal Mayors, DILG Regional Directors, ARMM Regional Governor, and all others concerned

4.0 Policy Content and Guidelines

4.1 The Dangerous Drugs Board will conduct IDMRIS end-user trainings in thirteen (13) Regions this year, with the following schedule and participants:
