OBSERVANCE OF THE LOCAL GOVERNMENT

MONTH, WEEK AND DAY

Presidential Proclamation No. 63 (s.1992), signed on October 2, 1992 declared October as the Local Government Month, the second week of October as the Local Government Week and the 10th day of October as the Local Government Day in the Philippines, in commemoration of the passage of the Local Government Code (LGC) of 1991.

In view thereof, all Local Government Units (LGUs) are encouraged to undertake, commemorative activities such as, but not limited to, the following:

- Barangay Assembly Day on the 8th day of October, with the theme, "Nagkakaisang Barangay: Lakas ng Kampanya Kontra sa Iligal na Droga, Krimen at Katiwalian. Makiisa! Makilahok! Makialam!"
- Forum in support of the government's campaign against illegal drugs, criminality and corruption;
- Share LGU best practices, through multi-media on becoming: a) business-friendly and competitive; b) socially-protective and safe; c) accountable, transparent, participative and effective; and/or d) environment-protective, disaster-resilient and climate change-adaptive; and
- Participate in activities that may be convened by the Department of the Interior and Local Government at the Central, Regional and Provincial Offices and other agencies and development partners; and

Highlighting the commemoration of the 26th Anniversary of the Local Government Code of 1991, a Consultation Workshop on the proposed amendments to the LG Code (October 6), the National LGU Information and Communication Technology Forum (October 19), and the Conferment of the Seal of Good Local Governance Award, will be conducted within the month of October.

All DILG Regional Directors are directed to cause the widest dissemination of this issuance in their respective regions.
