FAMILY PLANNING CONFERENCE (NFPC)

The Department of Health (DOH), the Commission on Population (POPCOM), Department of Health (DOH) and the Forum for Family Planning and Development, Inc. (Forum) are jointly organizing the 2nd National Family Planning Conference scheduled to take place on November 07-09, 2017 at Waterfront (Lahug) Cebu City Hotel. With the theme "Delivering the Promise: Family Planning on the Ground", this conference will be attended by various stakeholders namely: national and local government units (LGUs), development partners, the private sector, youth, women, persons with disabilities, indigenous people, the academe and civil society advocates and practitioner.

In this regard, all Local Government Units are encouraged to participate in above-mentioned activity. The conference has a registration fee of Php 3,000.00 per delegate/participant inclusive of Conference kit, Lunch and Snacks and all the information materials that will be used on the Day 0- Youth Conference, and Days 1-2- Conference Proper. Transportation, accommodation and other incidental expenses related to the event shall be shouldered by the participating LGUs chargeable against their respective local funds, subject to the usual accounting and auditing rules and procedures.
