ATTENDANCE TO THE 2017 CONSULTATIVE WORKSHOP ON

BARANGAY GRASSROOTS GOVERNANCE AND FEDERALISM OF

THE LIGA NG MGA BARANGAY SA PILIPINAS (LnB)

The Liga ng mga Barangay sa Pilipinas (LnB) will hold its 2017 Consultative Workshop on July 11-13, 2017 at Manila Hotel, City of Manila.

The objectives of the activity are 1) To orient and familiarize the general membership on federalism through the chapter presidents; 2) To establish strategic plans of actions consistent with devolution and federalist; 3) To discuss and hold consultations regarding issues on barangay election and other barangay reforms; and 4) To discuss and hold consultations on proposed legislative measures including proposed amendments to the local government code.

In this connection, through the request of Hon. Edmund R. Abesamis, LnB National President, all Regional/Provincial/City/Municipal LnB Presidents, Punong Barangays and other barangay officials from all over the country, are hereby encouraged to participate in the said activity on official business. The payment of applicable travelling expenses and a registration fee per participant, to defray the costs of hotel accommodation, meals and congress materials, may be authorized chargeable against their respective local funds, subject to the availability hereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations. Provided, however, that the travelling expenses and registration fee shall not be charged against the 20% component of the Internal Revenue Allotment or from whatever source which may prejudice poverty reduction efforts.

The LnB-National President shall submit a post-activity report to the Undersigned, through the National Barangay Operations Office, within one (1) month after the conduct of the said assembly.

All DILG Regional Directors and Field Officers are likewise directed to cause the dissemination of this Circular in their respective jurisdiction.
