**SUBJECT** 

: Orientation Seminar for the Permanent Action Team of the Cities of

Davao, Cebu and Metro Manila and the Municipality of Pateros in

Relation to Citizens' Complaint Hotline 8888

President Rodrigo Roa Duterte, in his desire to better serve the Filipino citizenry, issued Executive Order No. 6 "Institutionalizing the 8888 Citizens" Complaint Hotline and Establishing the 8888 Complaint Center" to encourage the people to report their complaints and grievances on acts of red tape or graft and corruption in the government bureaucracy.

Relative to this, Cabinet Secretary Leoncio B. Evasco, Jr. issued a Memorandum for all heads agencies, including the Local Government Units (LGUs), to designate an overall Permanent Action Team to answer the queries, concerns and complaints of the citizens through Hotline 8888. By the order of the President, said hotline should already be operational. DILG, therefore issued Memorandum Circular No. 2017-109, dated August 23, 2017, requiring all LGUs to designate a Permanent Action Team in their respective area of jurisdiction.

By invitation of the Office of the Cabinet Secretary, the Permanent Action Team, preferably the City Administrator (who shall act as the Permanent Focal person), an alternate Focal Person (who shall act on behalf of the Permanent Focal Person), and a Technical Person, who shall handle the software, of the LGUs of the Cities of Cebu, Davao, Metro Manila and the municipality of Pateros are hereby directed to attend the 8888 orientation seminar on February 8-9, 2018, at the 4<sup>th</sup> Floor, Mabini Hall, Malacañang Palace. The participants of this orientation-workshop shall be divided into two groups and will compose of the following LGUs:
