SUBJECT: 2018 18-DAY CAMPAIGN TO END VIOLENCE AGAINST

WOMEN (VAW)

Pursuant to Proclamation 1172, Series of 2006 which declares November 25 to December 12 of every year as the "18-Day Campaign to End Violence Against Women (VAW)" and Republic Act No. 10398, Series of 2012 which declares November 25 of every year as the "National Consciousness Day for the Elimination of Violence Against Women and Children," the Philippine Commission on Women (PCW) in coordination with the Inter-Agency Council on Violence Against Women and their Children (IACVAWC) is spearheading the observance of the 18-Day Campaign to End Violence Against Women (VAW) on November 25 to December 12, 2018.

The campaign theme for the period 2016-2021 is: "VAW-free community starts with Me." The theme shifts the 18-Day Campaign to End VAW to positive advocacy as it enjoins everyone to pursue the common vision of a VAW-free community, and highlights what can be done to achieve such.

The 2018 campaign shall focus on primary prevention to reduce incidents of VAW across the country. This can be achieved by helping people understand VAW from the point of view of victim-survivors. It is hoped that such deeper understanding would ignite compassion from stakeholders, so that they would not commit, condone, or remain silent about VAW. For service providers, such compassion towards victim-survivors would encourage them to provide better services to their clients.

To promote public awareness of VAW as an issue of national concern, all local government units (LGUs) are encouraged to undertake programs and activities relative to the theme and focus of the 2018 campaign, such as:

I. Production and distribution or exhibition of Information, Education and Communication (IEC) Materials

- a.) Hanging of 2018 18-Day Campaign to End VAW official streamer in all regional offices and local government units. Streamer design and guide for printing can be downloaded from the PCW website https://pcw.gov.ph/VAWfreePH2018.
- b.) Development, production and distribution of IEC materials for the 2018 18-Day Campaign to End VAW which include collaterals designed by PCW and agency-specific materials like Anti-VAW flyers. PCW-developed materials may be reproduced by agencies provided that the content and design of the material is retained. Printer-ready copy of the materials can be downloaded via https://tinyurl.com/Anti-VAW-IEC. The materials are designed for interested organizations to incorporate their official logo below the phrase "Reprinted and distributed by," so that due acknowledgment could be given for their contribution to the campaign.

II. Participation to 18-Day Campaign to End VAW online advocacy

- a.) Uploading of the official logo, advocacy videos and other 18-Day Campaign to End VAW advocacy materials in government agencies' website and social media accounts.
- b.) Participating in the online campaign thread about the observance by uploading photos, news features and other information relative to 18-Day Campaign to End VAW using the hashtag #VAWfreePH.
- c.) Simultaneous reading of prayer for VAWC victim-survivors during the November 26, 2018 Flag Raising Ceremony (Annex A).

III. Participation in PCW-organized 18-Day Campaign to End VAW information campaigns/advocacy activities

a.) 2018 VAW Experiential Museum (for LGUs in Greater Manila Area) – using participative theatre, the VAW Experiential Museum is an effective way to make the public understand the difficult experiences of VAW victim-survivors by making use of their senses (see, hear and feel) and appealing to their emotions.

The event is open to the public for free, but with limited viewing capacity. The participation of youth (age 15-30) is encouraged. Interested parties should register through the PCW website https://pcw.gov.ph/VAWfreePH2018 and be guided by the details below.
