14TH WOMEN WITH DISABILITIES DAY CELEBRATION

Memorandum Circular No. 2018-32

1. Background

At . per

- 1.1 The total development and empowerment of women is a State policy enshrined in the 1987 Philippine Constitution which specifically provides that "The State recognizes the role of women in nation-building, and shall ensure the fundamental equality before the law of women and men" (Section 14, Article II);
- 1.2 Proclamation No. 744 dated 6 December 2004 titled "Declaring the Last Monday of March Every Year as "Women with Disabilities Day" emphasizes the inclusion of women with disabilities within the society and as such deserve equal rights in the field of law and in all aspects of human endeavor.

2. Purpose

This Memorandum Circular is issued to encourage all local government units to observe and conduct appropriate activities relative to the celebration.

3. Scope/Coverage

All Provincial Governors, City/Municipal Mayors, Punong Barangays, DILG Regional Directors, ARMM Regional Secretary and all others concerned.

4. Policy Content and Guidelines

- 4.1. The Women with Disabilities Day for this year shall be observed on March 26, 2018
- 4.2. The 2018 celebration revolves around the theme "#Progress to Success: Babaeng Maykapansanan sa Pagbabago, Manguna at Manindigan Ka" that highlights the potentials of women with disabilities and the need to empower them as agents of change.

- 4.3 All Local Government Units are enjoined to conduct appropriate activities, mindful of the theme and their contribution to the objectives of the celebration. Activities may include:
 - 4.3.1 Forum on Employment and Entrepreneurship for Women with Disabilities;
 - 4.3.2 Seminar on the Rights of Women with Disabilities;
 - 4.3.3 Talent Showcase of Women with Disabilities;
 - 4.3.4 Hanging of Streamers in conspicuous places (design and specifications can be downloaded at www.ncda.gov.ph).
- 4.4 All Regional Directors are hereby directed to conduct related activities at your level, extend full support to LGUs for the meaningful observation of "Woman with Disabilities Day" and cause widest dissemination of this circular.
