2018 WORLD YOUTH CAMP

The City Government of Tagum, in partnership with the International Youth Fellowship (IYF) will be conducting the "2018 World Youth Camp" on April 16-19, 2018 at the Energy Park, Apokon, Tagum City. Participants to the activity are youth delegates from the Philippines, South Korea, Asia, Africa and other interested countries.

The objectives of the youth camp are: (1) promote self-improvement through leadership lectures, mind lectures and group presentations; and (2) learn teamwork and cultural appreciation through cultural and recreation and performances.

In view of the above, all Provincial Governors, City and Municipal Mayors, and Punong Barangays are encouraged to: (1) inform and mobilize the youth leaders within their areas of jurisdiction as participants to the youth camp; and (2) sponsor or grant financial assistance for the registration fees in the amount of *One Thousand Five Hundred Pesos (Php1,500.00)* for each participant, chargeable against local funds, subject to the availability thereof, and to the usual accounting and auditing requirements and to all pertinent laws, rules and regulations.

The IYF, through Mayor Rellon, shall submit a post-activity report to the DILG Secretary, through the National Barangay Operations Office, within a month after the conduct of the said activity, with the following prescribed format:

- A. Executive Brief;
- B. List of Participants;
- C. Outputs of Technical Sessions;
- D. Issues and Agreements or Recommendations, if any;
- E. Total Fees Collected and Disbursed; and
- F. Appendices, if any.
