INVITATION TO BID FOR THE PROVISION OF VEHICLE RENTAL FOR THE MONITORING AND EVALUATION OF SUPPORT TO BARANGAY DEVELOPMENT PROGRAM PROJECTS AND OTHER LOCALLY FUNDED PROJECTS FOR THE 2ND SEMESTER CY 2021

1. The **Department of the Interior of Local Government – Region XII**, through the GENERAL APPROPRIATIONS ACT(GAA) FY 2021intends to apply the sum of **SIX HUNDRED THOUSAND PESOS (P600,00.00)**being the ABC to payments under the contract for Provision of vehicle rental for the Monitoring and Evaluation of Support to Barangay Development Program Projects and other Locally Funded projects for the 2nd semester CY 2021.**Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The **Department of the Interior of Local Government – Region XII**now invites bids for the above Procurement Project.**Delivery of the Goods is required not later than twenty (20) calendar days including Saturdays, Sundays, and Holidays from the receipt of Notice to Proceed (NTP).** Bidders should have completed, within *the prescribe period* from the date of submission and receipt of bids, a contract similar to the Project.The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary **“pass/fail”** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. *Under Section 23.4.1.2 of the 2016 revised IRR of RA No. 9184 do not exist:]* Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 - b. **BIDDING IS OPEN TO ALL QUALIFIED BIDDERS**,subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from **Department of the Interior of Local Government (DILG) – Region XII** through its **Regional Bids and Awards Committee (RBAC)** from **8:00 AM to 5:00 PM (Monday – Friday)** excluding Saturdays, Sundays, and Holidays.

8. **ALL BIDS MUST BE ACCOMPANIED BY A BID SECURITY IN ANY OF THE ACCEPTABLE FORMS AND IN THE AMOUNT STATED IN ITB CLAUSE 14.**

9. **BID OPENING SHALL BE ON JULY 21, 2021 (WEDNESDAY), 10:00 A.M. via VIDEO CONFERENCE. BIDS WILL BE OPENED IN THE PRESENCE OF THE BIDDER OR HIS/HER AUTHORIZED REPRESENTATIVE WHO CHOOSE TO ATTEND THE ACTIVITY.**

10. The *Department of the Interior and Local Government (DILG) – Region XII* reserves the right to reject any and all bids, declare a failure of bidding, or not
