The Department of the Interior and Local Government Regional Office XII (DILG- RO XII), through the National Expenditure Program (NEP) FY 2020³ intends to apply the sum of Four Million Two Hundred Seventy Thousand Pesos (Php 4,270,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for Supply and delivery of two (2) unit Motor Vehicles for the transportation of Personnel, Equipment, Supplies, Products and Materials of DILG XII. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Delivery of the Goods is required **not later than March 16, 2020, (45 cd)**. Bidders should have completed, within *the prescribed period* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from the Department of the Interior and Local Government (DILG) – Region XII, Prime Regional Government Center, Brgy. Carpenter Hill, Koronadal City, South Cotabato Province and inspect the Bidding Documents from 8:00 A.M. – 5:00 P.M., Monday – Friday.

4. A complete set of Bidding Documents may be acquired by interested Bidders starting January 10, 2020 (Friday) to January 28, 2020 and upon payment of the applicable fee in the amount of Five Thousand Pesos Only (Php 5,000.00) for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 5. The Department of the Interior and Local Government (DILG) Region XII will hold a Pre-Bid Conference⁵ on January 17, 2020 (Friday), 10:00 A.M. at DILG Regional Office XII Conference Room, Prime Regional Government Center, Brgy. Carpenter Hill, Koronadal City, South Cotabato Province, which shall be open to prospective bidders.
- 6. Bids must be duly received by the BAC Secretariat at the address below on or before January 29, 2020, 10:00 A.M. at DILG Regional Office XII Procurement Unit, Prime Regional Government Center, Brgy. Carpenter Hill, Koronadal City, South Cotabato Province. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on <u>January 29, 2020 (Wednesday), 10:00 A.M.</u> at *DILG Regional Office XII - Conference Room, Prime Regional Government Center, Brgy. Carpemter Hill, Koronadal City, South Cotabato Province*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. <u>LATE BIDS SHALL NOT BE ACCEPTED</u>.
